Unit description

The music industry is among the largest worldwide, and music is a pervasive part of our lives. We turn on music while driving, we listen to music at parties, bars and restaurants. We dance to music, shop to music, sing in the shower, and attend concerts. Yet the psychological and social significance of this aspect of our lives is not widely understood. The goal of this unit is to expose students to the psychological and semiotic dimensions of music in everyday experience. The unit examines current psychological research on music, and explores the social significance of music using a semiotic approach. By the end of the unit, students have an understanding of the cognitive and emotional implications of music, and have the semiotic skills to critically analyse the layers of significance associated with a range of musical genres, from hip-hop and heavy metal, to opera and chamber music.

The Group Audio-Visual Project provides students with an opportunity to apply skills and knowledge they have gained in the unit in a creative group task. Each student is assigned a particular role within the group and is marked for their contribution in that role. The project is due in week 12.

Early assessment

Weighting: **20%**

The midterm test is a 45-minute multiple-choice examination that will be held in class during week 4. The test assesses your understanding of lecture topics and reading materials in weeks 1-3 only, providing a low-risk means of evaluating your potential early in the course.

Project write-up

This assessment task provides students with the opportunity to reflect on their group project, to identify strengths and weakness of group members. Although the audio-visual project is completed in groups, the write up must be your own individual work. The final completed write-up is due in week 13 at the tutorial but you are expected to make some contributions to the write-up each week.

Final exam

Weighting: **40%**

A three-hour examination comprised of short-answer and multiple-choice answer questions. The examination provides students with the opportunity to demonstrate their breadth of knowledge. All unit material is examinable. It provides a final summative assessment of the students' understanding of unit content and their ability to apply that knowledge.
