Group performance experiment

Due: **Week 3-6**

Weighting: **15%**

Small groups of students work together to produce a work-in-progress performance.

Students' group performance experiments will be assessed in terms of level of memorization, movement and blocking, overall effect, ensemble effect, and response to challenges.

Participant observation

Due: **Week 3-7**

Weighting: **25%**

Students' engagement with their performance projects, including class discussion in W7, will be judged on the basis of their journal entries.

Journal entries will be assessed in terms of quality of description, relevance, analysis, effort, and presentation.

Individual oral presentation

Due: **Week 11-13**

Weighting: **30%**

Students deliver oral presentations discussing their performance experiments with relevant theories and artworks.

Student oral presentations will be assessed in term of presence, organization, content, visual aids, and overall impression.

Final essay

Due: **November 14**

Weighting: **30%**

Developing from their oral presentations, students write essays discussing the experiments in relation to relevant theories and artworks.

Student essay will be assessed in terms of organisation, protocols, analytical thinking, and thematics.
