#### Unit description

Topics include: constitution and governmental structure; legal system and its role in business relations; contract law; corporation law and corporate governance; the main types of financial institutions and the regulatory authority; labour law; intellectual property law; and taxation. Students having satisfactorily completed the unit will have basic knowledge and understanding about the characteristics and principal elements of the aforesaid topics. The contents of and the issues raised in the unit are of benefit to all students and particularly to those who intend to pursue careers involving business in or trade with Japan.

On average, 1-2 hours per week from Week 1 to Week 12.

#### Class Test 1

Criteria for assessment are: students' understanding of the materials, knowledge, and ability to analyse and evaluate issues concerning the topics covered in the unit for the test (detailed explanations of the assessment criteria provided on the iLearn site of the unit).

It is an Open Book test. It is a test with short-answer questions. Information about Class Test 1 (including materials allowed to be brought to Class Test 1 and the syllabus of Class Test 1) will be announced in the Lecture in Week 3 (10 March 2015).

Class Test 1 is a 30-minute test. It will be held during the time for the Lecture in Week 6 (on 31 March 2015 Tuesday).

Students are expected to present for Class Test 1 at 4:00 p.m. on 31 March 2015 at the venue for the BUSL377 lecture or such another venue as announced on the iLearn site of this unit.

The only exception to not sitting Class Test 1 at the designated time is because of documented illness or unavoidable disruption. In these circumstances, students may wish to consider applying for Special Consideration under the University's Disruption to Studies Policy, which is available at: http://mq.edu.au/policy/docs/disruption\_studies/policy.html. If a Supplementary Test is granted, the Supplementary Test will be scheduled by the Unit Convenor.

The marked Tests will be returned to the students in Week 7. Feedback to individual students is

given in writing on the marked tests. Feedback will also be given to students verbally in the lecture in Week 7 in the form of an explanation on the correct answers, common mistakes, and the level of difficulty (low, medium and high) of the questions.

#### **Estimated Student Workload (outside class time)**

On average, 2 hours per week from Week 1 to the date of Class Test 1 (31 March 2015) in Week 6.

#### **Class Test 2**

Criteria for assessment are: students' understanding of the materials, knowledge, and ability to analyse and evaluate issues concerning the topics covered in the unit for the test (detailed explanations of the assessment criteria provided on the iLearn site of the unit).

It is an Open Book test. It is a test with short-answer questions. Information about Class Test 2 (including materials allowed to be brought to Class Test 2 and the syllabus of Class Test 2) will be announced in the Lecture in Week 10 (12 May 2015).

Class Test 2 is a 60-minute test. It will be held during the time for the Lecture in Week 13 (on 2 June 2015 Tuesday).

Students are expected to present for Class Test 2 at 4:00 p.m. on 2 June 2015 at the venue for the test, which will be announced via the iLearn site of this unit.

The only exception to not sitting Class Test 2 at the designated time is because of documented illness or unavoidable disruption. In these circumstances, students may wish to consider applying for Special Consideration under the University's Disruption to Studies Policy, which is available at: http://mq.edu.au/policy/docs/disruption\_studies/policy.html. If a Supplementary Test is granted, the Supplementary Test will be scheduled by the Unit Convenor.

The marked Tests will be returned to the students within the Week commencing on 9 June 2015.

### **Estimated Student Workload (outside class time)**

On average, 2 - 2.5 hours per week from Week 6 to the date of the Class Test 2 (2 June 2015) in Week 13.

#### **Essay**

Students will be required to submit an Essay (excluding footnotes and bibliography: 2,800-3,000 words).

The Essay topic and Instructions will be posted on iLearn in Week 3.

The Essay is research based. Students will not be able to rely simply on the required and/or recommended reading materials for classes. Students will be expected to conduct their own research. The Essay is a task for each individual student. Collective or collaborative work is NOT ACCEPTABLE.

Footnotes and bibliography (in Australian Guide to Legal Citation (3rd ed) style) are required.

Criteria upon which the Essay is assessed are: the contents, structure, presentation, and referencing (footnoting and bibliography) of the essay which show the students' understanding of the materials, the depth of arguments and critique, the thoroughness of legal research, and adequacy of referencing (detailed explanations are provided on the iLearn site of this Unit).

Students must hand in the Essay <u>before 4:00 p.m. on **10 June 2015**</u> to: <u>BESS (Business and Economics Student Services)</u> at **E4B 106**.

In view of the time given to students to complete the Essay, no extensions will be granted. Late essays will be accepted up to 48 hours after the submission deadline. There will be a deduction of 20% of the total available marks made from the total awarded mark for each 24 hour period or part thereof that the submission is late (for example, 25 hours late in submission – 40% penalty). For example, if the Essay is worth 40 marks, a student is 23 hours late in submission and (before penalty) this student's mark is 30, the penalty will be a deduction of 8 marks (40 marks x 20% = 8 marks) (i.e. this student will obtain 22 marks for the Essay). This penalty does not apply for cases in which an application for special consideration is made and approved.

# Changes from Previous Offering

As compared with the offering in 2014, the main changes are:

1. There are slight changes in the learning outcomes: Item 1, replacing the words "Recognise and explain" by "Recognise, explain and critique"; Item 2, replacing the

- words "Identify and discuss" by "Identify, discuss and critique"; and Item 4, replacing the words "Carry out" by "Conduct and carry out".
- 2. Instead of having one Class Test (with a weighting of 30%), there will be two Class Tests (one with a weighting of 15% and the other with a weighting of 25%).
- 3. The Final Examination (with weighting of 50%) has been replaced by an Essay, which has a weighting of 40%.
- 4. There may or may not be Guest Lecture this year. Except this, there are no changes to the topics to be covered but their order/sequence has been slightly changed.
- 5. An essay-writing workshop is to be held in tutorial classes in Week 6 to enhance students' understanding about academic essay-writing.
