Unit description

This unit aims to help students of ancient history develop their knowledge of the Latin language. It continues the systematic introduction to the grammar and vocabulary begun in unit AHIS118. The unit also aims to help students build skills in reading original Latin literary and documentary texts, and analyse the significance of Latin for the study of relevant ancient cultures.

### Participation

Due: **Weekly**

Weighting: **10%**

The purpose of this low-risk assessment is to test engagement with unit content and developing knowledge and skills. You will be required to participate in class discussions exploring aspects of unit content. These discussions, spaced through the teaching session, will be conducted for both internal and external students via the General Discussion Forum on the unit's iLearn page. A week before each topic closes for marking purposes a warning message will be posted on the Discussion Forum. Note the key word 'participation'. You need to post before deadlines and it is important to be aware that posting after Week 13 is not satisfactory.

The criteria against which this assessment will be assessed are level of engagement and demonstration of developing knowledge and skills. There will be four discussion topics. The minimum length of post on each topic is 30 words, the maximum 300 words.

For each topic one mark is available for engagement and one mark for demonstration of developing knowledge and skills. There are two marks available for effective participation in **all four** topics.

## Quizzes

Weighting: **15%**

The purpose of this assessment task is to continue developing control over Latin grammar and vocabulary, analytical skills, comprehension, and independent thinking. In each of the five electronic grammar quizzes you will be required to answer five questions.

The criteria against which this task will be assessed are accuracy and completeness of the information you present.

## Prose Compositions

Due: **See unit schedule**

Weighting: **20%**

The purpose of this assessment is to facilitate understanding of Latin grammatical structures. You will be required to translate a series of sentences from English into Latin (five sentences in each of the four assignments). The sentences will test your control over concepts discussed in the lectures and the grammar booklet and (often) illustrated in the unit readings.

The assessment criteria against which this task will be assessed are accuracy, completeness, and technical and stylistic control over the material.

- Recognize and memorize extended Latin vocabulary
- Assess the grammar required for the translation of Latin texts appropriate to this level of study
- Explore and appraise relevant grammatical and lexical reference tools

## Document analysis

Due: **See unit schedule**

Weighting: **15%**

The purpose of this assessment is to develop analytical skills and independent thinking. You will be required to investigate a passage drawn from the unit readings and to provide a linguistic analysis of specific grammatical features (to be advised) appearing in that passage. Length-limit: 1000 words, including analysis and bibliography.

The assessment criteria against which this task will be assessed are accuracy, thoroughness, clarity of presentation, and effective use of referencing and bibliography.

## Examination

Due: **See unit schedule**

Weighting: **40%**

The purpose of this assessment is to test general control over unit content. The closed-book examination, which has a duration of two hours plus 10mins reading time, is arranged as 4 questions:

- in Question 1 you will be required to translate from Latin into English three short passages drawn from the unit readings (48% of exam. weighting);
- in Question 2 you will be required to explain specific grammatical features in four short extracts drawn from the unit readings (20% of exam. weighting);
- in Question 3 you will be required to reproduce four of the grammatical paradigms from the grammar booklets for Latin A and Latin B (12% of exam. weighting);
- in Question 4 you will be required to translate four English sentences into Latin (20% of exam. weighting), using constructions studied and vocabulary used in the prose compositions and sample sentences for this unit.

The criteria against which this task will be assessed are accuracy and completeness of the translation in Question 1 and of the responses in Questions 2 and 3 and technical and stylistic control of the translations in Question 4.
