Written Examination

Only non-programmable calculators that do not have text retrieval capacity are allowed.

We primarily use the software package R in this Unit. R is becoming increasingly important for statisticians and other scientists. More information about R can be found at the web site <http://www.r-project.org/> and the package can be downloaded **free of charge** from there. R is very similar to the package S-PLUS and most of its codes will also work in S-Plus. From week 2, students will be given exercises each week covering materials from the lectures, and most exercises

require using R.
