Unit description

This unit provides students with the opportunity to acquire a deeper understanding of Japan through research on a particular subject. After choosing a research topic in consultation with the unit convenor, students undertake a 5000-6000 word research paper. Within the framework of Japanese studies, research topics can be chosen from a wide spectrum of Japan related fields including: Japanese language; literature; manga/anime; culture; history; economics; politics; social and contemporary issues; and international relations involving Japan. Japanese native speakers may enrol in this unit.

Research Proposal

Due: Sat 20 August (Week 3)

Weighting: 20%

Students are required to submit the research paper abstract (300 words), research action plan (300 words) and annotated bibliography (minimum 20 relevant, appropriate sources). Instructions, template and marking criteria will be found in iLearn.

Draft Research Paper

Students are required to submit a complete draft of the fully and correctly referenced research paper. Instructions and marking criteria will be found in iLearn.

Research Paper Presentation
