Unit description

This unit (Research Proposal) is the compulsory prerequisite unit for PSY934 (Dissertation). The objective of PSY933 is for students to conduct a literature review, as well as plan and design their empirical project for their thesis (which will be subsequently completed in PSY934). All students will be required to have a research supervisor from a member of staff from the Department of Psychology. The supervisor will assist the student to meet the objectives of this unit as well as for the Dissertation Unit (PSY934). The Seminars for PSY933 will also facilitate students to plan and fine-tune their research project which must have relevancy to Clinical Psychology. The goals of the unit are to encourage review and consideration of background literature, to prepare a literature overview and proposed method, and to prepare an ethics submission for the empirical thesis.

Delivery and Resources

This unit is the compulsory pre-requisite unit for PSY934 – Research Dissertation. The research proposal unit prepares students to complete their research dissertation.

During the Research Proposal unit, students are required:

- · To attend 6 seminars in Session 1, 2017
 - Seminar Dates: 28 Feb 2017; then 5 consecutive Tuesdays in May (2nd to 30th May)
 - Room: W6B 357 Meeting room
- Find a supervisor who is willing to supervise dissertation who is a member of staff in the Dept of Psychology.
- Complete first draft of literature review paper to satisfactory standard pending feedback from supervisor, no later than 3rd November 2017
- Plan and design research project and submit complete protocol to Macquarie University
 Ethics Committee no later than 3rd November, 2017

The first draft of the literature review paper will form the literature review paper for the Dissertation unit. The research project design will form the empirical paper for the dissertation.
