Unit description This unit draws on knowledge from across the International Relations program, requiring candidates to apply their earlier learning to an urgent and/or controversial theme in international relations – i.e. an international political problem. The participatory exercises are simulations that involve role playing. They require students to acquire (i) some specialist and general theoretical knowledge; (ii) to develop and apply negotiation, communication and practical problem solving abilities; (iii) enhance research and writing skills.
