Unit description

Terrorism is a controversial issue in part because of the debates and confusions around how best to defend against it. This unit will build on PICX802 by critically examining a range of themes central to effective practical counterterrorism, from a community, state, regional and global perspective. Strategic and tactical counter terrorism will be explored with particular focus on key concepts such as radicalization and de-radicalisation, countering violent extremism, and understanding terrorist narratives and counter narratives. Wider issues contextualising the sociology and anthropology of terrorist violence will be considered, as will ethical debates concerning appropriate counterterrorism response, how terrorism ends, and the relationship between counterterrorism and human rights. Active Participation

Due: **Ongoing** Weighting: **10%**

Critical Literature Review

Due: Sunday of Week 5

Weighting: 40%

This assessment requires you to compare, contrast, and critically assess two peer-reviewed

academic journal articles on counter-terrorism. You will be expected to identify and cogently argue the strengths and weaknesses of these articles, and contextualise them within the broader field of counter-terrorism studies. Further instructions on this assignment will be available to enrolled students through the iLearn site. Additional information will also be communicated in lectures. This task is due at midnight on the Sunday of Week 5.

Research Essay

Due: Sunday of Week 11

Weighting: 50%

This assignment requires you to write a sustained 3500 word critical research essay on a key scholarly debate relating to countering terrorism and/or countering violent extremism. The essay will demonstrate you have critically engaged with contemporary literature on counter terrorism and countering violent extremism, that you have critically evaluated a range of perspectives, and synthesised them into a coherent and appropriately evidenced argument. A series of essay questions will be displayed through the iLearn site and students are required to select one question from the list. Instructions on the essay questions and further guidance for this task are available to enrolled students on the iLearn site, and will be communicated in lectures. This task is due at Midnight on the Sunday of Week 11.

SUBMITTING ASSESSMENT TASKS

- All text based assessment tasks are to be submitted, marked, and returned electronically. This will only happen through the unit iLearn site.

LATE SUBMISSION OF ASSESSMENT TASKS

- If an assignment is submitted late, 5% of the available mark will be deducted for each day (including weekends) the paper is late.
- For example, if a paper is worth 20 marks, 1 mark will be deducted from the grade given for each day that it is late (i.e. a student given 15/20 who submitted 4 days late will lose 4 marks = 11/20).
- The same principle applies if an extension is granted and the assignment is submitted later than the amended date.

WORD LIMITS FOR ASSESSMENT TASKS

- Stated word limits include footnotes and footnoted references, but not bibliography, or title page.
- Word limits can generally deviate by 10% either over or under the stated figure.
- If the number of words exceeds the limit by more than 10%, penalties will apply. These penalties are 5% of the awarded mark for every 100 words over the word limit. If a paper is 300 words over, for instance it will lose 3 x 5% = 15% of the total mark awarded for the assignment. This percentage is taken off the total mark, i.e. if a paper was graded at a credit (65%) and was 300 words over, it would be reduced by 15 marks to a pass (50%).
