Unit description

Using anthropological and ethnographic studies, this unit focuses mainly on the social and cultural contexts of drug use, both legal and illegal. The unit is also concerned with economic and political factors influencing the production and distribution of drugs and the way in which these processes are enmeshed in a global economy. Topics include: the international traffic in opium/heroin and cocaine in the Golden Triangle of mainland South-east Asia and in South America and the way this traffic intermeshes with regional politics and local tribal, peasant and commercial systems of production and exchange; the social history of drugs in the US, UK and Australia; youth culture and drugs in the West; AIDS and intravenous drug use; addiction and treatment; drugs and the law; the global political economy of pharmaceuticals, particularly contraceptives, erectile dysfunction drugs, antiretrovirals in the age of AIDS; and the placebo effect.
