Unit description

This unit provides an academic foundation for student placements with international organisations. The unit examines key business decisions that are required in developing international organisational strategy taking into account a range of stakeholder perspectives. This experience requires students (working individually or in teams) to complete a major project or fill a business role within an international organisation. Students will work collaboratively with peers and an industry mentor or supervisor, and gain a sound understanding of the international business context.

## General Assessment Information

In order to complete the unit, students are required to complete the placement as agreed with their host organisation and the assessment tasks for the unit. Detailed instructions for each assessment task are available on iLearn. The instructions include information about content, submission methods, due dates, late penalties and marking guides or rubrics.

Task 1a, Task 2 and Task 3 must all be submitted via links on iLearn. Task 1b may either be signed, scanned and submitted via the link on iLearn or a hard copy may be submitted in a seminar by week 13. No extensions will be granted. There will be a deduction of 10% of the total available marks made from the total awarded marks for each 24 hour period or part thereof that the submission is late (for example, 25 hours late in submission - 20% penalty). This penalty does not apply for cases in which an application for disruption to studies is made and approved.

### Task 1 Placement evaluation

Due: **Wks 3,12**

Weighting: **30%**

Task 1 consists of two parts. In Task 1a (15% due in week 3) you complete an online self-evaluation and consult with your placement supervisor to draft development goals for your placement. In Task 1b (15% due in week 12) your supervisor completes an evaluation of your performance based on criteria in the *placement evaluation marking guide* (available on iLearn) and the development goals identified in Task 1a. You also evaluate your own performance based on your development goals.

Task 1a must be submitted through the link on iLearn. No hard copies will be accepted. Task 1b may either be signed, scanned and submitted via the link on iLearn or a hard copy may be submitted in a seminar by week 13. Marking criteria are available on iLearn.

In order to complete the unit, you must submit the placement evaluation. During the placement, the supervisor will assess student performance using the *supervisor's placement evaluation marking guide*. If performance is rated unsatisfactory at any time during the placement, you will be invited to a meeting to discuss your performance and develop a plan for improvement. If your performance does not improve to a satisfactory level, the placement may be discontinued. If your supervisor assigns a failing mark on the placement evaluation at the end of the semester, a penalty may be applied to the mark for Task 3, the final project.

No extensions will be granted. There will be a deduction of 10% of the total available marks made from the total awarded marks for each 24 hour period or part thereof that the submission is late (for example, 25 hours late in submission - 20% penalty). This penalty does not apply for cases in which an application for disruption to studies is made and approved.

## Task 2 Report

Due: **Week 8**

Weighting: **30%**

To prepare the Ethics and Sustainability Report, you need to identify one ethical situation and one issue relevant to sustainability in the organisation where you are completing your work placement. The examples may showcase ethical and sustainable choices, or they may highlight areas for improvement. Draw on academic literature to critically discuss the examples. Consider perspectives of a range of stakeholders, and make recommendations for improving practice. Reports must be submitted through the link on iLearn. No hard copies will be accepted. Detailed instructions and marking criteria are available on iLearn.

No extensions will be granted. There will be a deduction of 10% of the total available marks made from the total awarded marks for each 24 hour period or part thereof that the submission is late (for example, 25 hours late in submission - 20% penalty). This penalty does not apply for cases in which an application for disruption to studies is made and approved.

## Task 3 Final project

Due: **week 12**

Weighting: **40%**

For the final project, select a topic based on a theme from the unit (professional communication, organisational culture, business ethics or sustainability) that is relevant to your experience working for an international organisation. Identify a key message you have learned about that topic that you anticipate will be useful in future work or studies. Reflect on how best to communicate what you have learned to your peers and develop a teaching resource (comic book, video, blog, game, poster, instruction manual, etc.) to convey the lesson. You are required to submit a brief explanatory note to ensure the message is clearly communicated and the criteria for the assessment task have been met. Both the creative output (or a photograph/video of it) and the explanatory note must be submitted through the links on iLearn. The best examples may be selected for use (with permission) in future semesters.

For the final project, you will (1) develop a teaching resource and (2) provide feedback to your peers about their teaching resources. You will post your teaching resource to an online forum. You are expected to provide comments and/or constructive feedback for your peers. Marks are based on the teaching resource and an explanatory note (30%) and participation in the discussion forum (10%). Teaching resources are due by Wednesday of week 12 and forum comments must be added by Friday of week 12. Detailed instructions, marking criteria and template for explanatory note are available on iLearn.

No extensions will be granted. There will be a deduction of 10% of the total available marks made from the total awarded marks for each 24 hour period or part thereof that the submission is late (for example, 25 hours late in submission - 20% penalty). This penalty does not apply for cases in which an application for disruption to studies is made and approved.

**Note:** If your supervisor assigns a failing mark on the placement evaluation at the end of the semester, a penalty may be applied to the mark for Task 3, the final project.

- Critically reflect on experience in an international organisation to identify areas of key learning.

## **Delivery and Resources**

### **Class Timetable**

The class is run in internal mode. Because many of the unit hours are conducted at work placements, the on-campus portion of the unit is delivered via four 3-hour seminars. To complete the final project (Task 3), students may choose to use recording, production or editing software on a phone, tablet or computer.
