## Delivery and Resources

### Unit Organisation

This is a four credit point unit run over a 13 week session. This unit consists of multiple modes of delivery including lectures, master classes tutorials, workshops and showcases. Detailed information is available on the PHTY817 iLearn site, in the week-by-week timetable, posted in the *Important Documents* section.

### Assumed knowledge

This unit assumes knowledge from units delivered in Semesters A-D.

### Teaching and Learning Strategy

**Lectures and Masterclasses** Lectures in this unit will provide foundation knowledge about extended and enhanced scope practice for physiotherapists, including prescribing, imaging, and physiotherapy management in ICU and ED. Additionally, students will learn about recent research conducted by MQ Discipline of Physiotherapy academics and how this is translated into

clinical practice. Master classes will provide the opportunity for students to apply this knowledge to clinical scenarios and develop advanced clinical reasoning and practical skills in each of these areas.

**Expert Clinician Series:** Three expert clinicians will present a complex clinical case during the *Thursday Showcase* series. Each physiotherapy specialist will present a case based on their area of expertise, including neurological, musculoskeletal, and cardiorespiratory physiotherapy. After each presentation, the expert clinician will be available for a Q and A session, in which students have the opportunity to ask them questions about the reasoning behind aspects of their assessment and management of their patient, and thereby develop a deeper understanding of the clinical management in each case.

**Workshops:** Workshops will be held on topics such as Chronic Care Management, ICU management, Advanced Pain Management, Sleep Management and Women's Health. These workshops will provide opportunities for students to develop advanced practical skills, knowledge and clinical reasoning in these areas.

### **Attendance**

All lectures, workshops and tutorials are scheduled in your individual timetable. You may make a request to your tutor to attend a different tutorial on a one-off basis **for extenuating circumstances only**. In many cases masterclasses are recorded on Echo 360, however, attendance is expected at all times, as this is where the majority of learning occurs. Failure to attend may impact on your final results. It is the responsibility of students to contact their tutor by email to advise if they are going to be absent. ## Changes from Previous Offering

The assessment structure has been revised for the current iteration of the unit: the written exam and practical simulation have been replaced by an infographic and eportfolio. Unit content has also been revised to ensure that skills and information taught remains contemporary and topical. The casting workshop has been replaced with an advanced manual therapy workshop and workshops on Chronic Care Management and biomechanical approach to exercise prescription have been added.
