Unit description

This unit canvasses some of the major ethical, moral, and legal paradigms of thought within the field of Security Studies, and it considers how those paradigms might inform our approach to a number of controversial and consequential questions of security policy and practice.

Through both historical and contemporary case studies, students will examine and evaluate the ethical dimensions of various security-related issues such as the recourse to war, humanitarian intervention, wartime conduct, interrogation and torture, intelligence and surveillance, and human rights. Students will also consider cases of professional and workplace ethics in order to gain a greater appreciation of expected standards of conduct within the security sector.

### PACE Project

Due: **Week 6 (Plan); Week 11 (Final)**

Weighting: **60%**

Ethics of Security is a Professional and Community Engagement (PACE) unit. You will be placed in a small team of students and assigned to work on a project set by a partner organisation from

the public, private, or not-for-profit sector. Your team will mostly work independently, but a mentor from your partner organisation will be available to help guide you through the project. A project plan laying out how your team intends to approach the project will be due in Week 6, and the final results of your project will be delivered as both a written report and an oral presentation in Week 11 (unless your PACE mentor sets a different due date). ## Reflection

Due: **Week 13**

Weighting: **20%**

A small number of unassessed reflective exercises will be assigned during the course of the session, culminating in an assessed reflective task due in Week 13. These exercises will encourage students to reflect on both their past and future, including: what knowledge and skills they have learned over the course of the unit, and over the course of their program of study more generally; how they might apply their knowledge and skills beyond a university setting; how they work with and for others; what contribution they made to their PACE partner organisation; and what their career goals are and how they might best be achieved.

## LATE SUBMISSION OF ASSESSMENT TASKS

Unless a Special Consideration request has been submitted and approved, (a) **a penalty for lateness will apply** – two (2) marks out of 100 will be deducted per day for assignments submitted after the due date – and (b) **no assignment will be accepted seven (7) days (incl. weekends) after the original submission deadline**. No late submissions will be accepted for timed assessments – e.g. quizzes, online tests.

## WORD LIMITS FOR ASSESSMENT TASKS

- Stated word limits include footnotes and footnoted references, but not bibliography, or title page.
- Word limits can generally deviate by 10% either over or under the stated figure.
- If the number of words exceeds the limit by more than 10%, then penalties will apply. These penalties are 5% of the awarded mark for every 100 words over the word limit. If a paper is 300 words over, for instance, it will lose  $3 \times 5\% = 15\%$  of the total mark awarded for the assignment. This percentage is taken off the total mark, i.e. if a paper was graded at a credit (65%) and was 300 words over, it would be reduced by 15 marks to a pass (50%).
- The application of this penalty is at the discretion of the course convener.
