Unit description

PICX320 is designed to give students the opportunity to apply the insights they have developed over the course of their program to a practical problem in their field. Teams of students will work on projects set by, or in consultation with, partner organisations drawn from government, industry, and civil society. Alongside their project work, students will undertake some complementary career development exercises and consider what it means to think and act ethically in their chosen careers. After enrolling in PICX320, students should request a survey form by emailing arts.pace@mq.edu.au. The survey will be used to assign students to appropriate projects and teams.

PACE Project

Due: **Week 6 (Plan, Reflection & peer review); Week 11 (Final)**

Weighting: **60%**

Ethics of Security is a Professional and Community Engagement (PACE) unit. You will be placed in a small team of students and assigned to work on a project set by a partner organisation from the public, private, or not-for-profit sector. Your team will mostly work independently, but a mentor from your partner organisation will be available to help guide you through the project. A project plan laying out how your team intends to approach the project will be due in Week 6 (weighted: 20%), Midterm reflection and peer review (weighted: 10%) and the final results of your project will be delivered as both a written report and an oral presentation in Week 11 (unless

your PACE mentor sets a different due date) (weighted: 30%). More information on PACE for students is available at www.pace.mq.edu.au.

Reflection

Due: **Week 13**

Weighting: **20%**

A small number of unassessed reflective exercises will be assigned during the course of the session, culminating in an assessed reflective task due in Week 13. These exercises will encourage students to reflect on both their past and future, including: what knowledge and skills they have learned over the course of the unit, and over the course of their program of study more generally; how they might apply their knowledge and skills beyond a university setting; how they work with and for others; what contribution they made to their PACE partner organisation; and what their career goals are and how they might best be achieved.

UNIT REQUIREMENTS AND EXPECTATIONS

SUBMITTING ASSESSMENT TASKS

- All text-based assessment tasks are to be submitted, marked and returned electronically. This will only happen through the unit iLearn site.
- Assessment tasks must be submitted as a MS word document by the due date.
- Most assessment tasks will be subject to a 'Turnitin' review as an automatic part of the submission process.

LATE SUBMISSION OF ASSESSMENT TASKS

Unless a Special Consideration request has been submitted and approved, (a) **a penalty for lateness will apply** – two (2) marks out of 100 will be deducted per day for assignments submitted after the due date – and (b) **no assignment will be accepted seven (7) days (incl. weekends) after the original submission deadline**. No late submissions will be accepted for timed assessments – e.g. quizzes, online tests.

WORD LIMITS FOR ASSESSMENT TASKS

- Stated word limits include footnotes and footnoted references, but not bibliography, or title page.
- Word limits can generally deviate by 10% either over or under the stated figure.
- If the number of words exceeds the limit by more than 10%, then penalties will apply. These penalties are 5% of the awarded mark for every 100 words over the word limit. If a paper is 300 words over, for instance, it will lose $3 \times 5\% = 15\%$ of the total mark awarded for the assignment. This percentage is taken off the total mark, i.e. if a paper was graded at a credit (65%) and was 300 words over, it would be reduced by 15 marks to a pass (50%).
- The application of this penalty is at the discretion of the course convener.

REASSESSMENT OF ASSIGNMENTS DURING THE SEMESTER

4. substantially interfered with your otherwise satisfactory fulfilment of the unit requirements
5. lasted at least three consecutive days or a total of 5 days within the teaching period and prevented completion of an assessment task scheduled for a specific date.

If you feel that your studies have been impacted submit an application as follows:

2. Fill in your relevant details
3. Attach supporting documents by clicking 'Add a reply', click 'Browse' and navigating to the files you want to attach, then click 'Submit Form' to send your notification and supporting documents
4. Please keep copies of your original documents, as they may be requested in the

future as part of the assessment process
