Unit description

The unit provides a foundational overview of the theoretical perspectives that have contributed to the history and philosophy of early childhood education. It examines philosophies, theories and theorists over time that have helped shape views about children and children's learning, curriculum development and the role of the teacher. The unit will enable students to recognise the importance of philosophy in early childhood education as they read research and engage with philosophical ideas. Students will also begin to develop a broad knowledge of curriculum approaches, including Froebel, Montessori, Steiner and Reggio Emilia that are implemented across Australia in contemporary early childhood settings.

Draft Submissions & Turnitin Originality Reports

- Students may use Turnitin's Originality Report as a learning tool to improve their academic writing if this option is made available in the unit.
- Students are strongly encouraged to upload a draft copy of each assessment to Turnitin at least one week prior to the due date to obtain an Originality Report.
- The Originality Report provides students with a similarity index that may indicate if plagiarism has occurred. Students will be able to make amendments to their drafts prior to their final submission on the due date.

Assignment extensions and late penalties

Cr (Credit)	Provides evidence of learning that goes beyond replication of content knowledge or skills relevant to the learning outcomes. There is demonstration of substantial understanding of fundamental concepts in the field of study and the ability to apply these concepts in a variety of contexts; convincing argumentation with appropriate coherent justification; communication of ideas fluently and clearly in terms of the conventions of the discipline.
P (Pass).	Provides sufficient evidence of the achievement of learning outcomes. There is demonstration of understanding and application of fundamental concepts of the field of study; routine argumentation with acceptable justification; communication of information and ideas adequately in terms of the conventions of the discipline. The learning attainment is considered satisfactory or adequate or competent or capable in relation to the specified outcomes
F (Fail)	Does not provide evidence of attainment of learning outcomes. There is missing or partial or superficial or faulty understanding and application of the fundamental concepts in the field of study; missing, undeveloped, inappropriate or confusing argumentation; incomplete, confusing or lacking communication of ideas in ways that give little attention to the conventions of the discipline.

Weighting: **15%**

Students will choose one theory/theorist or topic to present on (20-30 min.) in the corresponding tutorial. Allocation of theory / theorist or topic will occur in week 1 or 2.

Students will work in pairs for this presentation and they are welcome to use a variety of media/ways to deliver their presentation. Students are encouraged to be creative in their presentation of the theory/theorist or topic.

Weighting: **35%**

This essay requires you to consider the diverse ways that early childhood education has been viewed in the past and today. You are required to research, compare and contrast at least two contemporary or historical media stories about early childhood education. You will construct an essay which must be submitted via Turnitin. You will need to draw on the compulsory readings and at least two more academic readings. The assignment will need to follow the APA referencing system.

Due: **Exam period**

Weighting: **40%**

Open book exam. Students will reply to **four out of a possible eight questions** covering the unit content (lectures; readings; presentations; discussions; activities etc). Please note that you will be able to have 10 pages of notes with you during the exams. However, this type of exam demands your critical thinking and synthesising skills (not memorization). This can be achieved via your weekly engagement with the readings/lectures and tutorial activities - working systematically throughout the session and not just before the exams.
