Unit description

This unit considers how and why the practices of intelligence professionals and the organisations in which those professionals work have changed over time. It covers both ancient and modern intelligence, but focuses mostly on the post-World War II era. In surveying this history of intelligence as part of the broader development of national security policies and institutions, the unit provides context for some of the debates and discussions around intelligence today. In closely examining selected case studies of intelligence success and failure, students will develop their own skills in historical and analytical thinking—skills that are integral elements of intelligence tradecraft. An online quiz will be available from 7pm Wednesday until 9am Monday in each of seven weeks across the unit. Each quiz (worth 5%) will test your knowledge of one module's assigned readings.

Analytical Essay

Due: **Variable**

Weighting: **25%**

A 1,500 word analytical essay that uses the assigned readings from a particular module to answer a set question. Each student will be assigned a different module, so due dates will vary. Essay questions and due dates will be assigned at the beginning of the unit.

On successful completion you will be able to:

- Demonstrate knowledge of the historical development of intelligence practices and organisations.
- Synthesize complex information relating to significant episodes of intelligence history, and weigh the merits of competing interpretations of those episodes.
- Assess the significance of particular concepts and debates within the academic field of Intelligence Studies, and evaluate their applicability to contemporary intelligence practice.
- Develop compelling and original arguments regarding intelligence practice, and clearly communicate those arguments in audience-appropriate formats (e.g., intelligence estimates, policy briefs, analytical essays).

Final Assessment

Due: **23/10 (Research Essay) or 30/10 (Take-Home Examination)**

Weighting: **40%**

Students choose one of two options for the final assessment. The first option is a research essay of 2,500 words on an intelligence history topic of their choosing. The second option is a take-home exam consisting of two questions, each requiring a written response of about 1,250 words (2,500 words total). Students who select this option will have one week to complete the take-home exam (23 October until 30 October).

- Assess the significance of particular concepts and debates within the academic field of Intelligence Studies, and evaluate their applicability to contemporary intelligence practice.

Delivery and Resources

UNIT REQUIREMENTS AND EXPECTATIONS

- You should spend an average of 12 hours per week on this unit. This includes listening to lectures prior to seminar or tutorial, reading weekly required materials as detailed in iLearn, participating in iLearn discussion forums and preparing assessments.
- Internal students are expected to attend all seminar or tutorial sessions, and external students are expected to make significant contributions to on-line activities.
- In most cases students are required to attempt and submit all major assessment tasks in order to pass the unit.

- The citations for all the required readings for this unit are available to enrolled students through the unit iLearn site, and at Macquarie University's library site. Electronic copies of required readings may be accessed through the library or will be made available by other means.

SUBMITTING ASSESSMENT TASKS

- All text-based assessment tasks are to be submitted, marked and returned electronically. This will only happen through the unit iLearn site.

- Most assessment tasks will be subject to a 'Turnitin' review as an automatic part of the submission process.

LATE SUBMISSION OF ASSESSMENT TASKS

Unless a Special Consideration request has been submitted and approved, (a) **a penalty for lateness will apply** – two (2) marks out of 100 will be deducted per day for assignments submitted after the due date – and (b) **no assignment will be accepted seven (7) days (incl. weekends) after the original submission deadline**. No late submissions will be accepted for timed assessments – e.g. quizzes, online tests.

WORD LIMITS FOR ASSESSMENT TASKS

- Stated word limits include footnotes and footnoted references, but not bibliography, or title page.
- Word limits can generally deviate by 10% either over or under the stated figure.
- If the number of words exceeds the limit by more than 10%, then penalties will apply. These penalties are 5% of the awarded mark for every 100 words over the word limit. If a paper is 300 words over, for instance, it will lose $3 \times 5\% = 15\%$ of the total mark awarded for the assignment. This percentage is taken off the total mark, i.e. if a paper was graded at a credit (65%) and was 300 words over, it would be reduced by 15 marks to a pass (50%).
- The application of this penalty is at the discretion of the course convener.

REASSESSMENT OF ASSIGNMENTS DURING THE SEMESTER
