Unit description

This unit introduces students to the dynamics of modern warfare. Students will learn about the application, the utility and the limitations of the use of military force. The unit introduces students to the origins of war, key approaches to war-fighting, the levels of war, as well as its costs and logistical processes. It teaches students different types of warfare and variation in how conflict is conducted. The unit also covers the impact of technological change on how modern warfare is conducted, and addresses the political and ethical considerations of their use in conflict. ### Policy Memo

Due: **Week 5**

Weighting: **25%**

The policy memo is a 1,000 word written brief addressed to a high-level policy-maker who is considering, but not committed to, the use of force in a particular situation to advance the government's interests. The memo will identify and analyze the political and strategic factors that should inform the policy-maker's decision, and recommend a particular course of action. Details will be provided on iLearn.

### Operations Analysis

Due: **Week 10**

Weighting: **40%**

The operations analysis is a 2,000 word paper examining all facets of a particular military operation. It requires a scholarly consideration of the background to the operation, the planning and conduct of the operation, and the implications of the operation for how observers understand

war in the twenty-first century. The particular operation to be analyzed will be provided on iLearn.

## Online Test

Due: **Week 13**

Weighting: **25%**

An online test will be administered in the final week of the unit to assess knowledge and understanding of all the unit materials, including lectures, case studies, and readings.

#### LATE SUBMISSION PENALTY

- Unless a Special Consideration request has been submitted and approved, (a) a penalty for lateness will apply – two (2) marks out of 100 will be deducted per day for assignments submitted after the due date – and (b) no assignment will be accepted more than seven (7) days (incl. weekends) after the original submission deadline.
- No late submissions will be accepted for timed assessments – e.g. quizzes, online tests.

#### WORD LIMITS FOR ASSESSMENT TASKS

- Stated word limits include footnotes and footnoted references, but not bibliography, or title page.
- Word limits can generally deviate by 10% either over or under the stated figure.
- If the number of words exceeds the limit by more than 10%, then penalties will apply. These penalties are 5% of the awarded mark for every 100 words over the word limit. If a paper is 300 words over, for instance, it will lose  $3 \times 5\% = 15\%$  of the total mark awarded for the assignment. This percentage is taken off the total mark, i.e. if a paper was graded at a credit (65%) and was 300 words over, it would be reduced by 15 marks to a pass (50%).
- The application of this penalty is at the discretion of the course convener.
