Critical Book Review

Due: Week 7 Weighting: 25%

Students will write and submit a 1,000-word long critical book review of a relevant book that will be prescribed in class. The review should meet **the appropriate quality standards for publication in academic journals**.

On successful completion you will be able to:

- Critique contemporary literature relating to the concepts of intelligence
- Demonstrate higher order communication skills including the ability to formulate sustained, persuasive and original written and oral arguments
- Model academic research skills, particularly the ability to select sources appropriately to integrate knowledge from diverse sources, to critically evaluate its significance and relevance, synthesise material and present finding logically, rationally and lucidly
- Evaluate how the intelligence function fits within the dynamic national security context
- Critically analyse a case study, demonstrating professional judgment and assessment.

An Analytical Essay

Due: Week 9 Weighting: 45%

Students will write and submit a 2,000-word long review essay which will situate, evaluate and compare different key texts that relate to the case study that will be used in the course. The relevant texts will be prescribed in class.

Take-Home Exam

Due: Week 12 Weighting: 30%

The exam will cover the main themes in the course, and will ask the students to critically reflect on the the roles and challenges of intelligence in the contemporary world. All exam answers combined are expected to total about 1,000 words.

LATE SUBMISSION OF ASSESSMENT TASKS

Unless a Special Consideration request has been submitted and approved, (a) **a penalty for lateness will apply** – two (2) marks out of 100 will be deducted per day for assignments submitted after the due date – and (b) **no assignment will be accepted seven (7) days (incl. weekends) after the original submission deadline**. No late submissions will be accepted for timed assessments – e.g. quizzes, online tests.

WORD LIMITS FOR ASSESSMENT TASKS

- Stated word limits include footnotes and footnoted references, but not bibliography, or title page.
- Word limits can generally deviate by 10% either over or under the stated figure.
- If the number of words exceeds the limit by more than 10%, then penalties will apply. These penalties are 5% of the awarded mark for every 100 words over the word limit. If a paper is 300 words over, for instance, it will lose $3 \times 5\% = 15\%$ of the total mark awarded for the assignment. This percentage is taken off the total mark, i.e. if a paper was graded at a credit (65%) and was 300 words over, it would be reduced by 15 marks to a pass (50%).
- The application of this penalty is at the discretion of the course convener.

REASSESSMENT OF ASSIGNMENTS DURING THE SEMESTER

If you feel that your studies have been impacted submit an application as follows:

- Attach supporting documents by clicking 'Add a reply', click 'Browse' and navigating to the files you want to attach, then click 'Submit Form' to send your notification and supporting documents
