### Clinical Placement SPHL832.1

Students will be assessed using the COMPASS competency-based assessment tool.

## Viva Examination SPHL832.3

Due: **Week 12-15**

Weighting: **20%**

Students will orally present a clinical case from their SPHL832.1 placement. The clinical case will be focused on speech pathology assessment.
