### Unit description

This unit gives students the opportunity to engage in the composition of a 6000 word self-directed research project, under the supervision of a subject area expert. This unit will necessitate students to thoroughly engage with the existing research on their topic, using it as a stepping-stone in developing their own research skills. Students will be mentored and trained on how to devise a research questions, translate this question into a set of research tasks, synthesise an appropriate methodological framework, conduct a literature review, collect data, and write up the result of their research as a coherent long research essay. This research relies on utilizing academic secondary sources and does not require original empirical work. Students intending to take this unit must contact the SSC Departmental Administrator, Michelle Lee, to discuss eligibility criteria and supervision arrangements at least two weeks before the start of semester.

## General Assessment Information

### SUBMITTING ASSESSMENT TASKS

- All text-based assessment tasks are to be submitted, marked and returned electronically. This will only happen through the unit iLearn site.
- Assessment tasks must be submitted as a MS word document by the due date.
- Most assessment tasks will be subject to a 'Turnitin' review as an automatic part of the submission process.

### LATE SUBMISSION OF ASSESSMENT TASKS

Unless a Special Consideration request has been submitted and approved, (a) **a penalty for lateness will apply** – two (2) marks out of 100 will be deducted per day for assignments submitted after the due date – and (b) **no assignment will be accepted seven (7) days (incl. weekends) after the original submission deadline**. No late submissions will be accepted for timed assessments – e.g. quizzes, online tests.

### WORD LIMITS FOR ASSESSMENT TASKS

- Stated word limits include footnotes and footnoted references, but not bibliography, or title page.
- Word limits can generally deviate by 10% either over or under the stated figure.
- If the number of words exceeds the limit by more than 10%, then penalties will apply. These penalties are 5% of the awarded mark for every 100 words over the word limit. If a paper is 300 words over, for instance, it will lose  $3 \times 5\% = 15\%$  of the total mark awarded for the assignment. This percentage is taken off the total mark, i.e. if a paper was graded at a credit (65%) and was 300 words over, it would be reduced by 15 marks to a pass (50%).
- The application of this penalty is at the discretion of the course convener.
