Project Management Assignment

This will be a written assignment, based on the content of the first six sessions of the unit.

Group Project Analysis

Due: **Week 10**

Weighting: **40%**

The assignment will require students to, (i) research and present an analysis of a completed project (such as a government construction project); (ii) to treat this group assignment as a mini-project, and to present an analysis of the effectiveness of the group at managing the mini-project. The exercise will allow you to gain teamwork experience and enhance your communication skills in a team environment. Both are essential for project management.

Although these are team exercises and as such reflect real world project management practice 50% of the mark awarded will be on an individual basis and the remainder allocated to the team. As such the report will need to list each student's contribution.

This assessment involves two specific tasks:

- **Task 1 Group Project Analysis Report:** Each group should submit **one** copy of your project analysis report of 3000-word to turnitin on the unit's ilearn website **by 6.00 pm Sunday 10th March (ie prior to Week 10)**. This is worth 30 %
- **Task 2 Group Project Analysis Presentation (Each student will be individually marked on their delivery):** Each group will present their project analysis in class in **Week 10**. They will also lead class discussion on the project and answer questions from fellow students. This is worth 10%

Further details of the assignment will be provided in class and on the unit's iLearn website **by Friday of Week 4**.

No extensions will be granted. There will be a deduction of 10% of the total available marks made from the total awarded mark for each 24 hour period or part thereof that the submission is late (for example, 25 hours late in submission – 20% penalty). This penalty does not apply for cases in which an application for disruption of studies is made and approved.
