Australia is rooted in a deep human and geological past which has profound meaning and resonance for contemporary Australian society. It has both Indigenous and non-Indigenous foundations. This unit explores these foundations from Indigenous occupation, through British contact and colonisation, to self-rule and the establishment of the 'white nation' in 1901. Through the themes of land, life and liberty, we trace the political, economic, cultural and social dynamics at play to discover what characterised the nation's beginnings.
