Unit description In this unit, you will pursue a course of collaborative enquiry-based learning with a supervisor by conducting a literature review. The literature review topics may be in the field of anatomy, surgery, radiology, ethics, history of medicine, medical education, medical devices and safety issues in clinical practice. This unit will develop your understanding of the different approaches to data collection and data analysis. You will produce a research paper, publishable in a peer reviewed journal, with emphasis on how to best construct data analysis, write scientifically and promote ethical research practices.
