Unit description

This unit introduces students to the discipline and study of criminology, including a broad overview of key developments, theories and practical implications. The intention is to situate criminology, and its various strands, within its particular social, political and intellectual contexts and to outline some of the key approaches associated with the field. Specifically, the unit is concerned with three broad and interrelated questions: 1) What and how societies define crime and harm in a particular way? 2) How theories of crime attempt to explain why certain people offend and certain crimes are committed? 3) What are the social responses to crime and how do institutions of criminal justice engage in mechanism of crime control?

## SUBMITTING ASSESSMENT TASKS

## LATE SUBMISSION OF ASSESSMENT TASKS

- Unless a Special Consideration request has been submitted and approved, (a) a penalty for lateness will apply – two (2) marks out of 100 will be deducted per day for assignments submitted after the due date – and (b) no assignment will be accepted seven (7) days (incl. weekends) after the original submission deadline. No late submissions will be accepted for timed assessments – e.g. quizzes, online tests.

## WORD LIMITS FOR ASSESSMENT TASKS

- Stated word limits include footnotes and footnoted references, but not bibliography, or title page.
- Word limits can generally deviate by 10% either over or under the stated figure.
- If the number of words exceeds the limit by more than 10%, then penalties will apply. These penalties are 5% of the awarded mark for every 100 words over the word limit. If a paper is 300 words over, for instance, it will lose  $3 \times 5\% = 15\%$  of the total mark awarded

for the assignment. This percentage is taken off the total mark, i.e. if a paper was graded at a credit (65%) and was 300 words over, it would be reduced by 15 marks to a pass (50%).

- The application of this penalty is at the discretion of the course convener.
