Unit description

This unit provides students with a deep understanding of the various dimensions, ideas and practices relating to successful leadership at the individual, group and organisational levels. Students will explore the cutting-edge academic research on leadership as well as learn practical skills directly from senior leaders in a range of fields. Skills developed in this unit will include the ability to build a strategic vision, to develop a sense of responsibility, to enhance group cohesion, and to influence and motivate a team to achieve a desirable end state. Students will also gain an understanding of how leadership differs across cultures, particularly between Eastern and Western societies. In the second half of the semester, this unit provides students with an opportunity to apply the knowledge they have gained throughout their program of study to a real world crisis. By participating in a dynamic simulation, students will be required to solve problems and find solutions to real world challenges. Students will be assigned to an executive team that includes students with different skill sets and knowledge. These executive teams may include strategists, intelligence analysts, criminologists, counter terrorism experts, and cyber security analysts. Students enrolled in Simulation and leadership in Security and Strategy will perform the role of the criminologist.

Ministerial Brief

Assessment Type ¹: Professional writing

Indicative Time on Task ²: 51 hours

Weighting: **30%**

Working as part of a team tasked with writing a ministerial brief/memo on a security and criminology-related scenario, Students write a Crime Threat Assessment; and contribute to the executive summary and recommendations in that assessment.

Main Simulation

Assessment Type ¹: Simulation/role play

Indicative Time on Task ²: 15 hours

Due: **Week 13-14**

Weighting: **30%**

Each student team will be presented with a simulation scenario. Each team will be required to provide policy recommendations to the control group (convenors) as the situation unfolds over a number of simulation moves or turns.

SUBMITTING ASSESSMENT TASKS

LATE SUBMISSION OF ASSESSMENT TASKS

Unless a Special Consideration request has been submitted and approved, (a) **a penalty for lateness will apply** – two (2) marks out of 100 will be deducted per day for assignments submitted after the due date – and (b) **no assignment will be accepted seven (7) days (incl. weekends) after the original submission deadline**. No late submissions will be accepted for timed assessments – e.g. quizzes, online tests.

WORD LIMITS FOR ASSESSMENT TASKS

- Stated word limits include footnotes and footnoted references, but not bibliography, or title page.
- Word limits can generally deviate by 10% either over or under the stated figure.
- If the number of words exceeds the limit by more than 10%, then penalties will apply. These penalties are 5% of the awarded mark for every 100 words over the word limit. If a paper is 300 words over, for instance, it will lose $3 \times 5\% = 15\%$ of the total mark awarded for the assignment. This percentage is taken off the total mark, i.e. if a paper was graded

at a credit (65%) and was 300 words over, it would be reduced by 15 marks to a pass (50%).

- The application of this penalty is at the discretion of the course convener.
