Unit description

This unit is offered on a pass/fail basis and designed for students who wish to complement their academic program through a short-term residential program relevant to their target language in International Studies: Languages and Cultures. This unit facilitates study at a partner university where intensive learning will take place in the student's target language and in regards to a topic relevant to their discipline. The program of study at the overseas institution will be approved and promoted by the Department of International Studies in collaboration with Macquarie International. The short period of intensive study is intended for students already studying a language at Macquarie, ideally those who are taking or have completed the introductory level(s). To be eligible to enrol in this unit, students will need to meet a range of selection criteria, including having a GPA of 4.5 at time of enrolment (and maintaining this by the time of enrolment in INTS3000) and completion of their second intermediate language unit before the time of enrolling in INTS3000.
