Unit description

This unit provides students with an opportunity to apply the knowledge acquired during their course to a real world crisis. After being exposed to theoretical concepts of scenario-building, role-playing and decision-making, students will experience the challenges of solving problems and finding solutions to real world crises during a dynamic simulation. They will be part of a team that includes students with different skill sets and knowledge, including strategists, intelligence analysts, criminologists, counter terrorism experts, and cyber security analysts. Students enrolled in Simulation in Security and Strategy will perform the role of the strategist. Their mission will be to formulate policy-oriented solutions by applying their theoretical knowledge and practical skills, for instance game theory. As part of a team, students will learn how to develop ministerial briefing papers during a crisis situation and how to make policy recommendations.

Ministerial Brief

Assessment Type ¹: Professional writing Indicative Time on Task ²: 51 hours Due: **Week 10** Weighting: **30%**

Working as part of a team tasked with writing a ministerial brief/memo on a security and criminology-related scenario, write a 'strategic assessment' and contribute to the executive summary and recommendations in that assessment.

On successful completion you will be able to:

- Apply classical and modern strategic analysis to complex and evolving real-world situations.
- · Communicate disciplinary knowledge to professional audiences.

Main Simulation

Assessment Type ¹: Simulation/role play Indicative Time on Task ²: 15 hours Due: **Week 11 and 12** Weighting: **30%**

Each student team will be presented with a war gaming scenario. Each team will be required to provide policy recommendations to the control group (convenors) as the situation unfolds over a number of simulation moves or turns.

- Apply classical and modern strategic analysis to complex and evolving real-world situations.
- Communicate disciplinary knowledge to professional audiences.

SUBMITTING ASSESSMENT TASKS

LATE SUBMISSION OF ASSESSMENT TASKS

Unless a Special Consideration request has been submitted and approved, (a) **a penalty for lateness will apply** – two (2) marks out of 100 will be deducted per day for assignments submitted after the due date – and (b) **no assignment will be accepted seven (7) days (incl. weekends) after the original submission deadline**. No late submissions will be accepted for timed assessments – e.g. quizzes, online tests.

WORD LIMITS FOR ASSESSMENT TASKS

- Stated word limits include footnotes and footnoted references, but not bibliography, or title page.
- Word limits can generally deviate by 10% either over or under the stated figure.
- If the number of words exceeds the limit by more than 10%, then penalties will apply. These penalties are 5% of the awarded mark for every 100 words over the word limit. If a paper is 300 words over, for instance, it will lose 3 x 5% = 15% of the total mark awarded for the assignment. This percentage is taken off the total mark, i.e. if a paper was graded at a credit (65%) and was 300 words over, it would be reduced by 15 marks to a pass (50%).
- The application of this penalty is at the discretion of the course convener.
