### Unit description

This unit provides students with opportunities to extend their understanding of appropriate responses to the diverse needs of young children in early childhood practice including consideration of personal and social attitudes towards people who experience disability. Students will be able to integrate their knowledge of child developmental processes and early childhood curriculum into a framework focusing on the social and educational development of young children who experience disability or difference, including inclusive approaches to teaching. Both theory and research-based practice will be explored, as well as the needs of families and how these intersect through social policy, service provision, early intervention and inclusive education.

### **Draft Submissions & Turnitin Originality Reports**

- Students may use Turnitin's Originality Report as a learning tool to improve their academic writing if this option is made available in the unit.
- Students are strongly encouraged to upload a draft copy of each assessment to Turnitin
  at least one week prior to the due date to obtain an Originality Report.

- The Originality Report provides students with a similarity index that may indicate if
  plagiarism has occurred. Students will be able to make amendments to their drafts prior
  to their final submission on the due date.

### Assignment extensions and late penalties

### Requesting a re-assessment of an assignment

# Student Project Part A

Assessment Type 1: Annotated bibliography Indicative Time on Task 2: 20 hours

Due: Week 5. 28/8/2020

Weighting: 25%

Identification of an issue for focus; explanation of the rationale behind this choice; preliminary bibliography of relevant research based on a database search (400 words); annotated bibliography of four journal articles (1200-1600 words).

Weighting: 35%

A review of the literature and articulation of strategies to address the chosen topic, including the development of practical ways to incorporate learning through this project into everyday early childhood practice (2500 words).
