Unit description

The unit introduces students to the principal areas of international trade law and policy, and in particular examines the legal regime governing the international exchange of goods, services, and intellectual property under the WTO. Topics include the WTO dispute settlement system; rules on non-discrimination; rules on market access; rules on unfair trade; preferential trade agreements.

General Assessment Information

Quizzes

Hypothetical problem assignment

The assignment involves a hypothetical problem question that tests students on a range of topics covered in this unit. It is designed to mimic the type of cases that international trade lawyers face in practice. More information about the assignment will be provided closer to the date.

Take-Home Exam

The take-home exam can include a range of short answer theoretical and problem questions, covering any topic from the entire semester. The take-home exam is released on the exam date at 9 am and is due by 12 pm on the same day. Late submissions will not be accepted. Assessment submissions

The convenor cannot provide extensions for assessments.
