#### Unit description

Environmental impact assessment (EIA) is a central decision-making process in many planning systems, and sets the agenda for ongoing environmental management of developments. This unit will enhance students' understandings of what EIAs are and how they are carried out in Australia and internationally. The unit will discuss formal government environmental impact assessment processes as well as the diverse ways in which non-government entities mobilise to assess environmental impacts. In particular, it will focus on how Indigenous peoples understand the environment and the multiple ways in which environment health and well-being is assessed and asserted through Indigenous governance and planning processes.

### Indigenous understandings of environmental health and wellbeing

Focusing on a case study, students will discuss Indigenous understandings of environmental health and well-being and make a case for how these understandings should be recognised and valued in governance and planning systems. 3000 words
