Unit description

This unit critically examines how the Australian government formulates its national security policy. The unit explores the historical development of Australia's national security policy by surveying the different cultural, political and geographic factors that have helped shape Australia's perceptions of its own security. The unit then pivots to discuss the most pressing national security challenges currently facing Australia. The unit concludes by examining current debates among Australian security scholars, practitioners and commentators on how best to respond to these emerging security threats and challenges. By the end of this unit, students will possess the ability to weigh different national security policy options and argue persuasively for their preferred course of action.

## Major Essay

## SUBMITTING ASSESSMENT TASKS

## LATE SUBMISSION OF ASSESSMENT TASKS

- Unless a Special Consideration request has been submitted and approved, (a) a penalty for lateness will apply – two (2) marks out of 100 will be deducted per day (including weekends) for assignments submitted after the due date – and (b) no assignment will be accepted seven (7) days (incl.weekends) after the original submission deadline. Late assessments will receive numerical feedback only (no comments). No late submissions will be accepted for timed assessments – e.g. quizzes, online tests.

## WORD LIMITS FOR ASSESSMENT TASKS

- Stated word limits include footnotes and footnoted references, but not bibliography, or title page.
- Word limits can generally deviate by 10% either over or under the stated figure.
- If the number of words exceeds the limit by more than 10%, then penalties will apply.

These penalties are 5% of the awarded mark for every 100 words over the word limit. If a paper is 300 words over, for instance, it will lose  $3 \times 5\% = 15\%$  of the total mark awarded for the assignment. This percentage is taken off the total mark, i.e. if a paper was graded at a credit (65%) and was 300 words over, it would be reduced by 15 marks to a pass (50%).

- The application of this penalty is at the discretion of the course convener.
