Unit description

This is a Professional Experience unit that builds upon the knowledge and understanding of assessment principles and classroom practices, and on using data to make informed pedagogical decisions and enhance student learning. The unit will focus on utilising data to develop effective teaching and learning activities for diverse learners. Strategies for behaviour and classroom management to ensure a supportive and safe learning environment will be explored. Students will link reflexive processes to planned actions to improve their teaching practice. Students will be required to work in a school under the guidance of a Supervising Teacher.

#### **Assessment Presentation and Submission Guidelines**

#### **Draft Submissions & Turnitin Originality Reports**

- Students may use Turnitin's Originality Report as a learning tool to improve their academic writing if this option is made available in the unit.
- Students are strongly encouraged to upload a draft copy of each assessment to Turnitin at least one week prior to the due date to obtain an Originality Report.
- The Originality Report provides students with a similarity index that may indicate if
  plagiarism has occurred. Students will be able to make amendments to their drafts prior
  to their final submission on the due date.
- Generally, one Originality Report is generated every 24 hours up to the due date.

HD (High Distinction)	Provides consistent evidence of deep and critical understanding in relation to the learning outcomes. There is substantial originality and insight in identifying, generating and communicating competing arguments, perspectives or problem-solving approaches; critical evaluation of problems, their solutions and their implications; creativity in application as appropriate to the discipline.
D (Distinction)	Provides evidence of integration and evaluation of critical ideas, principles and theories, distinctive insight and ability in applying relevant skills and concepts in relation to learning outcomes. There is demonstration of substantial understanding of fundamental concepts in the field of study and the ability to apply these concepts in a variety of contexts; convincing argumentation with appropriate coherent justification; communication of ideas fluently and clearly in terms of the conventions of the discipline.
P (Pass).	Provides sufficient evidence of the achievement of learning outcomes. There is demonstration of understanding and application of fundamental concepts of the field of study; routine argumentation with acceptable justification; communication of information and ideas adequately in terms of the conventions of the discipline. The learning attainment is considered satisfactory or adequate or competent or capable in relation to the specified outcomes
<b>F</b> (Fail)	Does not provide evidence of attainment of learning outcomes. ?There is missing or partial or superficial or faulty understanding and application of the fundamental concepts in the field of study; missing, undeveloped, inappropriate or confusing argumentation; incomplete, confusing or lacking communication of ideas in ways that give little attention to the conventions of the discipline.

Note: If you fail a unit with a professional experience component, the fail grade will be on your transcript irrespective of the timing of the placement.

#### Passing a Professional Experience Unit

In order to pass a Professional Experience unit, students must achieve a satisfactory result for their professional experience placement AND achieve a satisfactory result overall for their academic assessment tasks (where applicable) in the unit.

#### <u>Professional Experience Unit Placement Expectations</u>

- Students must be able to present evidence of completion of the following prior to session census date (or as otherwise advised) in order to receive a placement for Professional Experience:
  - A Working with Children Check or State/ Territory equivalent. For school placements this must be verified by DoE before your first placement. Complete

and email: The <u>practicum students declaration</u> and a copy of relevant ID documents to the department's <u>probity unit</u> at least two weeks prior to the start date of your first professional experience placement. You will also need to present photo ID on your first day of professional experience.

- Anaphylaxis training (practical and online training) (school placements only).
   Please note that Anaphylaxis training is only current for 2 years so students will need to update this, most probably at the start of their final year
- Read and acknowledge agreement to abide by the <u>DoE Code of Conduct</u> (school placements only)
- Child Protection Awareness Training (CPAT) (school placements only) (once only)
- Mandatory Child Protection Training (school placements only) (annually)
- Evidence of COVID-19 vaccination see SONIA for where you must submit your immunization evidence.

Students are responsible for ensuring that their evidence is current. Please be aware that you may need to update your training or credential during your program of study.

- A Working with Children Check or State/Territory equivalent is required by the end of Week 2 to be eligible for a placement. Students may need to withdraw from this unit if this has not been obtained in time.
- Students who are completing a unit offered by another department are expected to
  inform and negotiate with that unit convenor about their professional experience block
  dates and to discuss how that unit's requirements can be met. For some situations, it
  may mean that you are enrolled externally for that unit so that your attendance for
  tutorials for that unit is not impacted.
- Feedback from Tertiary Supervisors and/or Supervising Teachers is of a general nature.
   It is incumbent on the student to check the requirements of any assessments or

bookwork prior to submission.

- If a Student is identified being in need of additional support for Professional Practice
  and/or Bookwork, the <u>Department's 'Additional Support' procedure</u> will be activated
  and they will not be able to withdraw themselves from this Unit.
- The timing of placements can vary. For placements early in the Session, Fail grades may
  be approved by the University prior to the end of Session for students who do not meet
  the placement expectations of the Unit.

## **Acknowledgement of Country**

The mangroves are their nursery, their school and their home. The mangroves represent life – the obstacles and tangles that we need to navigate. Once we learn the right path to take, we are safe in that knowledge and in our lives"<sup>1</sup>.

- 2. Reflexive in their teaching practice
- 3. Responsive to children, colleagues, parents, professionals and communities
- 4. Ready to learn, and
- 5. Research engaged

In this unit you will learn using the 5Rs framework in the following ways:

RESILIENT	Students will need to balance a long PEx with their unit assessments as well as other life demands.
REFLEXIVE	Students are required to reflect on practice and act on their insights during PEx and for AT2.
RESPONSIVE	Students will respond to needs of students as well as the class in general during PEx.
READY TO LEARN	Constant reflection in and on practice means that students must be ready to learn from what they experience and apply it.
RESEARCH ENGAGED	Students will use current research to inform decisions and practice relating to student behaviour and learning.
