# Competency based assessment

In higher education, assessments must be able to recognise various levels of competencies in order to encourage students to become not only competent, but progress towards developing expertise. A key component of effective assessment in competency-based education is for assessments to be criterion-based using a developmental perspective. Defining the criteria in developmental terms, commonly called milestones or benchmarks, allows programs to determine whether the trainee is on an appropriate 'trajectory'.

Milestones provide specific guidance on trainee progress throughout the continuum of their training program. CHIR1102 practical examinations are competency based. For more information see: Competency-based Assessment, Macquarie University

### Late Submissions
