### Independent Research Report

Assessment Type <sup>1</sup>: Report

Indicative Time on Task <sup>2</sup>: 30 hours

Due: **From 26 December 2022 to 29 January 2023**

Weighting: **40%**

Students are required to prepare a final report that outlines the nature of the professional challenges in the legal workplace and the regulatory response to those challenges

### Engagement in unit and workplace tasks

Assessment Type <sup>1</sup>: Participatory task

Weighting: **30%**

Students will participate in online discussion, quizzes and problem solving tasks related to legal practice and regulation

## Skills Checklist and Goal Setting Exercise

## Delivery and Resources

### Late Assessment Submission Penalty

Unless a Special Consideration request has been submitted and approved, **a 5% penalty (of the total possible mark) will be applied each day a written assessment is not submitted**, up until the 7th day (including weekends). After the 7th day, a mark of '0' (zero) will be awarded even if the assessment is submitted. Submission time for all written assessments is set at 11.55pm. A 1-hour grace period is provided to students who experience a technical issue.

This late penalty will apply to non-timed sensitive assessment (incl essays, reports, posters, portfolios, journals, recordings etc). **Late submission of time sensitive tasks** (such as tests/exams, performance assessments/presentations, scheduled practical assessments/labs etc) **will only be addressed by the unit convenor in a Special Consideration application. Special Consideration outcome may result in a new question or topic.**
