The portfolio examiner will provide an aggregate grade for all eight capability aspects and a level of supervision for all 9 G EPAs and overall portfolio grade, all of which will be recorded in your Portfolio. During the examination/ interview, evidence of outstanding compulsory training requirements (such as requirements relating to family violence and mandatory reporting) and/or satisfactory resolution of academic concerns must be met in order to pass this hurdle assessment. Details of these training requirements will be provided within the detailed assessment guides, available on iLearn.
