### Data Analysis Project

Assessment Type <sup>1</sup>: Quantitative analysis task

A project will be designed to test the knowledge of data analysis using statistical software packages.

### Research Proposal

Assessment Type <sup>1</sup>: Project

Indicative Time on Task <sup>2</sup>: 30 hours

Due: **11:58 of Sunday in Week 12 (30 October)**

Weighting: **40%**

The task involves development of a research proposal, a presentation and an individual literature review. The group work (including research proposal and presentation) is worth 30% and the individual task (that is, the literature review) is worth 10%.

- Articulate research questions in response to a business problem or opportunity.
- Apply relevant methods to address finance issues or problems.
- Work productively in a group to design a research study.

## Assignment

Assessment Type <sup>1</sup>: Project

Indicative Time on Task <sup>2</sup>: 15 hours

Due: **Week 13**

Weighting: **45%**

The assignment will consist of two components. The first component will require students to use relevant software to conduct quantitative analysis. The second component will require students to use the research skills learned to evaluate and connect papers related to finance issues or problems.
