#### Unit description

This unit explores theories of learning in mathematics, science and technology for young children (birth to five years). Students will examine the specialist role of play and conceptual development in a range of early childhood settings. Current issues in research and practice will be investigated through independent study. Students acquire autonomy and expert knowledge of pedagogy and content for mathematics, science and technology as they design and evaluate learning experiences for young children.

The following generic grade descriptors provide university-wide standards for awarding final grades.

Grade	Descriptor
HD (High Distinction)	Provides consistent evidence of deep and critical understanding in relation to the learning outcomes. There is substantial originality and insight in identifying, generating and communicating competing arguments, perspectives or problem solving approaches; critical evaluation of problems, their solutions and their implications; creativity in application as appropriate to the discipline.
D (Distinction)	Provides evidence of integration and evaluation of critical ideas, principles and theories, distinctive insight and ability in applying relevant skills and concepts in relation to learning outcomes. There is demonstration of frequent originality in defining and analysing issues or problems and providing solutions; and the use of means of communication appropriate to the discipline and the audience.
Cr (Credit)	Provides evidence of learning that goes beyond replication of content knowledge or skills relevant to the learning outcomes. There is demonstration of substantial understanding of fundamental concepts in the field of study and the ability to apply these concepts in a variety of contexts; convincing argumentation with appropriate coherent justification; communication of ideas fluently and clearly in terms of the conventions of the discipline.
P (Pass).	Provides sufficient evidence of the achievement of learning outcomes. There is demonstration of understanding and application of fundamental concepts of the field of study; routine argumentation with acceptable justification; communication of information and ideas adequately in terms of the conventions of the discipline. The learning attainment is considered satisfactory or adequate or competent or capable in relation to the specified outcomes
F (Fail)	Does not provide evidence of attainment of learning outcomes. There is missing or partial or superficial or faulty understanding and application of the fundamental concepts in the field of study; missing, undeveloped, inappropriate or confusing argumentation; incomplete, confusing or lacking communication of ideas in ways that give little attention to the conventions of the discipline.

- Understanding family perspectives on maths and science and creating teaching and learning content that generates connections between children, families, educators and teachers Assessments 1 & 2)
- Understanding broader implications of technology and how this influences teaching and learning decision (Assessment 2)

### Responsive:

- Recalling our own learning experiences and reflecting on what makes a good teacher/
   what pedagogical practices they found negative
- Building passion, interest and enthusiasm for maths and science and developing strategies for supporting that response/ disposition/ experience for children and families
- Recognising how children's interest in technology and multimedia are important as an impetus for curriculum planning/ implementation (in both digital and non-digital play) (Assessments 1 & 2)

#### Ready to learn:

- Reinforcing the teacher's role as co-learner learning alongside children on maths and science content
- Understanding technology as tool for teaching and learning (Assessments 1 & 2)

#### Research Engaged:

• Drawing on research to explain maths identity and anxiety (Assessments 1 & 2)
