Unit description

Transnational security challenges pose major problems for many states, including Australia. They also challenge the traditional conceptual foundations of international security studies based on the primacy and sovereignty of the state. For example, human migration, drug trafficking, environmental change, and organised crime contribute to the internal instability of developed as well as the developing states. In some instances, resource scarcity can even lead to interstate conflict. However, new and innovative analytical concepts are required to develop a clear appreciation of the specific nature of individual transnational problems and adequate responses. This unit will examine the theories and analytical instruments needed to critically analyse different transnational security challenges. It also examines the multi-dimensional nature of security - political, economic, military, social and cultural - and the often-intimate connection between these seemingly separate spheres or entities.

SUBMITTING ASSESSMENT TASKS

LATE SUBMISSION OF ASSESSMENT TASKS

Unless a Special Consideration request has been submitted and approved, a 5% penalty (of the total possible mark) will be applied each day a written assessment is not submitted, up until the 7th day (including weekends). After the 7th day, a mark of '0' (zero) will be awarded even if the assessment is submitted. Submission time for all written assessments is set at 11.55pm. A 1-hour grace period is provided to students who experience a technical issue. This late penalty will apply to written reports and recordings only. Late submission of time sensitive tasks (such as tests/exams, performance assessments/presentations, scheduled practical assessments/labs will be addressed by the unit convener in a Special consideration application.

WORD LIMITS FOR ASSESSMENT TASKS

- Stated word limits include footnotes and footnoted references, but not bibliography, or title page.
- Word limits can generally deviate by 10% either over or under the stated figure.
- If the number of words exceeds the limit by more than 10%, then penalties will apply. These penalties are 5% of the awarded mark for every 100 words over the word limit. If a paper is 300 words over, for instance, it will lose $3 \times 5\% = 15\%$ of the total mark awarded for the assignment. This percentage is taken off the total mark, i.e. if a paper was graded at a credit (65%) and was 300 words over, it would be reduced by 15 marks to a pass (50%).
- The application of this penalty is at the discretion of the course convener.
