Unit description

This unit introduces students to scenario planning and simulation (serious game) techniques as critical thinking tools in the context of security policy analysis and planning. In the first modules, students are introduced to the broad logic and use of scenarios and simulations, as well as to their strengths and weaknesses. The second part of the unit is structured around one main contemporary security and criminology-related question that is examined in detail using scenario planning techniques and the conduct of a serious game. Students enrolled in this will take the role of the cyber security analyst.

## Ministerial Brief

Assessment Type <sup>1</sup>: Professional writing

Working as part of a team tasked with writing a ministerial brief/memo on a security and criminology-related scenario, write a 'Cyber Threat Assessment'; and contribute to the team executive summary and recommendations

## Main Simulation

Assessment Type <sup>1</sup>: Simulation/role play

Indicative Time on Task <sup>2</sup>: 15 hours

Due: **Week 13-14**

Weighting: **35%**

Each student team will be presented with a simulation scenario. Each team will be required to provide policy recommendations to the control group (convenors) as the situation unfolds over a number of turns

## SUBMITTING ASSESSMENT TASKS

- All text-based assessment tasks are to be submitted, marked and returned electronically. This will only happen through the unit iLearn site.

- Most assessment tasks will be subject to a 'Turnitin' review as an automatic part of the submission process.

## LATE ASSESSMENT SUBMISSION PENALTY

Unless a Special Consideration request has been submitted and approved, **a 5% penalty (of the total possible mark) will be applied each day a written assessment is not submitted**, up until the 7th day (including weekends). After the 7th day, a mark of '0' (zero) will be awarded even if the assessment is submitted. Submission time for all written assessments is set at 11.55pm. A 1-hour grace period is provided to students who experience a technical issue.

This late penalty will apply to written reports and recordings only. **Late submission of time sensitive tasks** (such as tests/exams, performance assessments/presentations, scheduled practical assessments/labs **will be addressed by the unit convenor in a Special consideration application.**

## WORD LIMITS FOR ASSESSMENT TASKS

- Stated word limits include footnotes and footnoted references, but not bibliography, or title page.
- Word limits can generally deviate by 10% either over or under the stated figure.
- If the number of words deviates from the limit by more than 10%, then penalties will apply. These penalties are 5% of the awarded mark for every 100 words over the word limit. If a paper is 300 words over, for instance, it will lose  $3 \times 5\% = 15\%$  of the total mark

awarded for the assignment. This percentage is taken off the total mark, i.e. if a paper was graded at a credit (65%) and was 300 words over, it would be reduced by 15 marks to a pass (50%).

- The application of this penalty is at the discretion of the course convener.
