Unit description

This unit provides students with practical opportunities to further develop their translation competence. Students will practice translating a range of domain-specific texts common in professional practice. The unit takes a problem-based approach encouraging students to identify and discuss problems encountered in the course of translation related to textual, stylistic, register, and language usage issues. Students will learn about, apply and evaluate strategies to solve the more challenging translation problems.

Assessment Type 1: Translation Indicative Time on Task 2: 18 hours Due: **Various due dates** Weighting: **40%**

Assignments include three types of tasks: English into LOTE, LOTE into English, and Revision. About 3000 words in total. (about 750 words each assignment)

End of Semester Examinations English into LOTE

Assessment Type 1: Examination Indicative Time on Task 2: 3.5 hours Due: **Week 14** Weighting: **30%**

Students are provided with three examination options to choose from:

- Complete two English texts to be translated into LOTE and one English into LOTE revision task (30%) and two LOTE texts to be translated into English and one LOTE into English revision task (30%); or
- 2. Complete two English texts to be translated into LOTE and one English into LOTE

revision task only (60%); or

3. Complete two LOTE texts to be translated into English and one LOTE into English revision task only (60%).
