## General Assessment Information

### Professional Experience Unit Placement Expectations

- Students must be able to present evidence of completion of several tasks prior to session census date (or as otherwise advised) in order to receive a placement for Professional Experience. ## 5R's Framework

The 5Rs Framework, developed by the School of Education at Macquarie University, is embedded throughout your teacher education course.

Your use of the 5Rs Framework will help you develop the capabilities that will make your teaching career sustainable and fulfilling.

In this unit, you will learn using the 5Rs framework in the following important ways:

- Reflexivity: regularly returning to a scenario, problem or question, or specific element of professional practice to reflect on and make decisions about appropriate action in

response to the distinctive core of a given subject, changing educational structures and contexts, and personal values and beliefs about teaching overall.

- Research-engaged: through an exploration and application of empirical research about professional practice in the secondary education classroom
