Unit description

This unit aims to enable students to become independent users of the French language. The work in this unit is of a very intensive nature. The unit aims to develop students' language skills to B1 level in the Common European Framework of Reference for Languages (CEFRL).

## General Assessment Information

### Late Assessment Submission Penalty

Unless a Special Consideration request has been submitted and approved, **a 5% penalty (of the total possible mark) will be applied each day a written assessment is not submitted, up until the 7th day (including weekends)**. After the 7th day, a mark of '0' (zero) will be awarded even if the assessment is submitted. Submission time for all written assessments is set at 11.55pm. A 1-hour grace period is provided to students who experience a technical issue. This late penalty will apply to non-timed sensitive assessment (incl essays, reports, posters, portfolios, journals, recordings etc). Late submission of time sensitive tasks (such as tests/exams, performance assessments/presentations, scheduled practical assessments/labs etc) will only be addressed by the unit convenor in a Special consideration application. Special Consideration outcome may result in a new question or topic.

### To be very clear:

- *Unless you have applied for special consideration and had your application approved, for each day your assignment is late, 5% of the total possible marks will be deducted. For example, if you submit your assignment 7 days late, 35/100 marks will be deducted from your actual mark.*
- *If your assignment is more than 7 days late (including weekends), you will get 0 for your assignment.*

These are serious penalties that will substantially alter your final grade and even determine whether you pass or fail this unit. Please make every effort to submit your assignment by the due date.

## Common European Framework of Reference (CEFR)

This unit prepares students to the **Level B1** of the Common European Framework of Reference for Languages.

**Level B1** reflects the **Threshold Level** specification for a visitor to a foreign country and is perhaps most categorised by two features. **The first feature is the ability to maintain interaction and get across what they want to, in a range of contexts**, for example: generally follow the main points of extended discussion around him/her, provided speech is clearly articulated in standard dialect; give or seek personal views and opinions in an informal discussion with friends; express the main point they want to make comprehensively; exploit a wide range of simple language flexibly to express much of what they want to; maintain a conversation or discussion but may sometimes be difficult to follow when trying to say exactly what they would like to; keep going comprehensively, even though pausing for grammatical and lexical planning and repair is very evident, especially in longer stretches of free production.

**The second feature is the ability to cope flexibly with problems in everyday life**, for example cope with less routine situations on public transport; deal with most situations likely to arise when making travel arrangements through a third-party or when actually travelling; enter unprepared into conversations on familiar topics; make a complaint; take some initiatives in an interview/consultation (e.g. to bring up a new subject); ask someone to clarify or elaborate what they have just said.
