Unit description

You will engage in integrated learning about reporting data, study design, data analysis and interpretation, and critical appraisal of research papers in public health. Learning activities will include lectures, tutorials, and online activities. By completing this unit, you will gain knowledge and skills which will enable you to locate, produce and appraise evidence in the field of public health.
