Grading of Assessments

You will receive a grade for each assessment within this unit. The grades awarded will reflect a holistic evaluation of the work against the criteria outlined within the corresponding assessment rubric. Numerical marks will be calculated for each assessment based on the following percentages, and rounded to the nearest full mark:

- High distinction (HD) – 95%
- Distinction (D) – 80%
- Credit (C) – 70%
- Pass (P) – 60%
- Pass minus (P-) - 50%
- Fail (F) – 40%

Submission of an incomplete assessment task may result in the Fail (F) grade to be awarded a numerical grade below 40%.

Late Submissions

Unless a Special Consideration request has been submitted and approved, a 5% penalty (OF THE TOTAL POSSIBLE MARK) will be applied each day an assessment is not submitted, up until the 7th day (including weekends). After the 7th day, a grade of '0' will be awarded even if the assessment is submitted. Submission time for all written assessments is set at 11.55pm. A 1-hour grace period is provided to students who experience a technical concern.

You will also need to allow approximately 75 hours for assessment based work.

Changes from Previous Offering

Assessment task changes have occurred following feedback from previous offerings. A case conference viva has been introduced, and the group project has been altered to a group presentation based on a complex case, to more specifically align with unit content. The complex case portfolio has been reduced in size and weighting and is no longer a hurdle. Extra assessment preparation sessions have been included in the unit schedule to further support students with assessment tasks.
