Unit description This unit focuses on how policy is made and who makes it. Taking an international perspective, the unit introduces students to the policy process, the state and societal actors that cooperate (and fight) over policy and to the context in which they operate. Students will engage in peer learning, discuss cases studies as well as write on policy issues using the materials and concepts presented in the unit.

## General Assessment Information

### Late Assessment Submission Penalty

## Essay

Indicative Time on Task <sup>2</sup>: 55 hours

Weighting: **40%**

The essay provides students with the opportunity to explore a topic of interest in depth. Students should develop a considered answer to a specific question based on reading a range of sources.
