Unit description

This unit offers an introduction to: developmental and acquired brain impairment and how this can affect day to day functioning; emotional and psychological reactions to brain impairment; the neuropsychologist's role in intervention; recovery and rehabilitation following acquired brain impairment; models and theories of rehabilitation; and developing and evaluating intervention programs. The unit covers both child and adult neuropsychological intervention.

Assignment 1: Case Description Critique

Assessment Type ¹: Case study/analysis

Indicative Time on Task ²: 15 hours

Due: **10/09/23**

Weighting: **20%**

Students submit a critique of a case scenario describing the condition (onset, nature, severity) of cognitive, emotional, behavioural impairments, and/or other anomalies and the disabilities arising from them, as well as relevant psychosocial /other background details within the context of what information/details are required and need to be considered for a successful neuropsychological intervention.

- Describe the neuropsychologist's role in rehabilitation/intervention.
- Design, implement and evaluate neuropsychological intervention programs within the context of a multi-disciplinary team.

Assignment 2: Intervention goals and strategies

Assessment Type ¹: Case study/analysis

Indicative Time on Task ²: 20 hours

Due: **1/10/23**

Weighting: **30%**

Students submit a description of intervention goals relating to a specific case, including GAS scaling for 2-3 goals. Students will discuss the models and approaches pertinent to the goals for the case, providing the rationale and justification for their approach, linking the goals to the intervention strategies

Exam

Students will complete a written examination that includes multiple-choice and short answer questions, with questions drawn from lecture content and essential readings.
