Late Submissions

Critical Review

Assessment Type ¹: Project

Indicative Time on Task ²: 50 hours

Weighting: **60%**

Students will submit a critical review of the literature pertaining to a specific topic that contributes

to either a: program or service evaluation study; study based on an experimental single case design; pilot study and grant application; systematic review or meta-analysis; qualitative or quantitative study using primary or secondary data analyses; or a capstone experience in which a question is posed, and evidence is gathered to answer that question.

On successful completion you will be able to:

- Develop a critical review of the literature pertaining to a specific topic that contributes to knowledge in the context of organisational psychology.
- Apply ethical principles to research and the different research paradigms in organisational psychology.
- Use oral and written communication to effectively communicate with peers.

Ethics Application

Assessment Type ¹: Professional writing

Weighting: **20%**
