Unit description

In this unit, students will be introduced to advanced issues in the description, assessment, differential diagnosis, and treatment of acquired speech and language disorders in adults; particularly, aphasia and dysarthria. Disorders of motor functioning and lexical, syntactic, and discourse processing will be addressed, as well as their consequences for communication. Students will explore relevant speech pathology assessment and intervention, and critically evaluate the research evidence supporting their use.

For example: Word limit = 2000 words; Submission word count = 2240, i.e., 12% over the limit, and therefore a penalty is applied as follows:

- Initial grade = D
