Unit description

This practical writing unit reflects on the dynamic relationships that exist between creative writing practice and digital, networked and interactive cultures. Students will be introduced to techniques in authoring short-form narrative or poetry-based digital and interactive works, exploring technological and literary questions relating to the writing and production of digital works. Students will engage with open-source software and network media to develop skills that advance their digital literacy. At the end of the unit students will have utilised two or more technologies in the writing and production of a minor and major digital creative work.

## General Assessment Information

### Late Assessment Submission Penalty

Weighting: **40%**

Students will utilise two or more technologies in the writing and production of a major digital creative work, and have published these works to the web.

- Plan and produce short-form digital text-based creative works in two or more technologies.
