Unit description

In this unit, you are introduced to clinical problem-solving and differential diagnosis. You will develop the knowledge and skills to assess and report on the health status of an individual. An emphasis will be placed on the assessment of musculoskeletal conditions relevant to chiropractic practice and the recognition of conditions outside the scope of chiropractic care that will require referral to other health practitioners.
